CARE has withdrawn the rating assigned to the bank facilities of Acme Solar Energy (Madhya Pradesh) Private Limited with immediate effect, as the company has fully repaid the amounts under the said facilities and there is no amount outstanding under the facilities as on date.

About the Company

Acme Solar Energy (Madhya Pradesh) Private Limited (ASEMPPL), a 100% subsidiary of Acme Solar Energy Private Limited (ASEPL), has set up a 25 MW solar power project based on Photo Voltaic (PV) technology using Poly-Crystalline & Thin Film PV modules in the state of Madhya Pradesh under the Madhya Pradesh state solar policy. The company is supplying power from the entire capacity at Rs.8.05/kWh to MPPMCL under a 25-year PPA. The project cost of Rs.208.78 crore (Rs.8.35 crore/MW), was funded through equity of Rs.64.71 crore, term loans of Rs.130 crore and balance funding through promoter unsecured loans. The engineering, procurement and construction contract (EPC) for the project was done by Acme Cleantech Solutions Private Limited (ACSPL, rated CARE BBB+/CARE A2) on a fixed time-fixed price basis and the project was commissioned in January 2014.
