Detailed Rationale & Key Rating Drivers

The ratings factor in consistently strong financial as well as business performance of Indiabulls Housing Finance Limited (IBHFL) and comfortable capitalization levels. The ratings are further supported by diversified resources profile, good asset quality, experienced management and comfortable liquidity profile. The ratings also take into account the risk associated with large size corporate mortgage loans. Asset quality, profitability, credit concentration and capitalization are the key rating sensitivities.

Detailed description of the key rating drivers

Key Rating Strengths

Strong financial and business performance: IBHFL has consistently shown strong growth in financial as well as business performance which can be witnessed by CAGR growth of 25% during FY12-FY17 in its total income to Rs.11,702 crore during FY17. The assets under management (AUM) at a consolidated level also grew at a CAGR of 27% during FY12-FY17 to Rs.91,301 crore as on March 31, 2017 with a mix of mortgage loans [including individual home loans and loan against property (LAP)] constituting 78% of AUM and corporate mortgage loans constituting 22% of AUM.

Comfortable capitalization levels and diversified resources profile: The capitalization levels are comfortable with reported Capital Adequacy Ratio (CAR)² of 20.91% (Tier I CAR- 17.25%) as on March 31, 2017 (March 31, 2016: CAR- 23.38%, Tier-I CAR- 20.36%). IBHFL has got diversified resource raising ability with borrowings in form of Bank Facilities [41.8%], Non-Convertible Debentures (NCDs) [40.4%], Commercial Paper (CP) [12.4%], External Commercial Borrowings (ECBs) [3.0%], Subordinate Debt [2.3%] and Perpetual Debt [0.1%] as on March 31, 2017.

Good asset quality: IBHFL has maintained its asset quality with Gross NPA Ratio and Net NPA Ratio [on balance sheet loan portfolio] of 0.94% (P.Y.: 0.95%) and 0.40% (P.Y: 0.39%) as on March 31, 2017. The Net NPA to tangible net-worth ratio stood at 2.73% as on March 31, 2017 vis-à-vis 2.24% as on March 31, 2016.

Experienced management team: The management team of IBHFL is headed by Mr. Sameer Gehlaut, Founder-chairman and Executive Director and is ably supported by Mr. Gagan Banga, Vice-Chairman and Managing Director (MD) and senior management people with strong relevant experience and successful track record in their respective fields.

Comfortable liquidity profile: The liquidity profile as on March 31, 2017 was comfortable with cumulative positive mismatches across all time buckets. IBHFL's policy to have 15-20% of its total assets in cash & cash equivalent helps it in better liquidity management and overcome any temporary liquidity crisis in the market.

Key Rating Weaknesses

Risk associated with large size corporate mortgage loans: The corporate mortgage portfolio mainly includes lease rental discounting and residential construction finance. High borrower concentration and relatively riskier nature of the corporate mortgage portfolio can put stress on asset quality in times of economic turbulence in the future. The top 10 corporate loan accounts (on a group basis) constituted 54% (P.Y.: 56%) of tangible net-worth as on March 31, 2017.

Analytical approach: CARE has analyzed IBHFL's credit profile by considering the consolidated financial statements of IBHFL owing to financial and operational linkages between the parent and its subsidiaries and common management.
