# CARE REAFFIRMS RATINGS ASSIGNED TO BANK FACILITIES OF NUPOWER RENEWABLES PVT LIMITED

## **Rating Rationale**

The reaffirmation of the rating of the bank facilities of NuPower Renewables Pvt Limited (NRPL) continues to positively build in the experience of management team in renewable power generation segment, financial patronage from promoters and long-term Power Purchase Agreements (PPA) signed with various State Electricity Boards (SEBs) yielding steady cashflows. The rating also derives strength from the improvement in the receivables position post the financial restructuring of Tamil Nadu Generation and Distribution Corporation (TANGEDCO; rated CARE A-(SO)).

The above rating strengths are tempered by dependence of power generation on seasonal wind patterns, exposure to regulatory and market risk for GBI and REC related cash flows, moderate debt coverage indicators and counter party risk arising out of exposure to State Electricity Boards (SEBs) with weak financial profile.

Ability to achieve envisaged Plant Load Factor (PLF), timely realization of receivables from SEBs and timely commissioning of 49.2 MW additional capacity in Maharashtra remain the key rating sensitivities.

#### **Background**

NuPower Renewables Pvt Limited. (NRPL), incorporated on December 24, 2008, is promoted by Mr. Deepak V. Kochhar and Supreme Energy Private Ltd (SEPL). NRPL currently has operational wind farms with an aggregate capacity of 149.15 MW located in Tamil Nadu (134.75 MW), Karnataka (10.2 MW) and Rajasthan (4.2 MW). The company proposes to setup additional capacity of 49.20 MW in the State of Maharashtra to de-risk the revenue base.

During FY14, NRPL reported total income of Rs. 133.91 crore up 12.59 % y-o-y as compared to Rs. 118.94 crore in FY13. In FY14, company reported net loss of Rs. 11.92 crore.
