Rating Rationale

The tourism rating assigned to Pranava Homestay derives strength from the favourable location with regards to accessibility as well as vicinity to tourist destinations in and around Mysore and compliance with various statutory requirements.

The rating is however constrained by limited track record of operations, moderate infrastructure facilities, lack of trained & skilled human resources constraining basic services and minimal safety and security measures.

Background

Pranava Home Stay (PHS) was established in 2016 by Mrs. Shivamma S. R. (Wife of Mr. Jayakumar S.). PHS is located at the first floor of 664, Pranava Yogadhama, 7th Main, First Stage, Vijayanagar, which is one of the residential areas of Mysore. The owners reside at the ground floor of the building. The home stay has five semi-furnished rooms with attached bathrooms fitted with western commode & 24x7 cold/hot water supply, wardrobes, Wi-Fi and electricity backup. PHS also has a common dining area with fully equipped kitchen, water purifier, refrigerator, gas connection and utensils.

Mr. Jayakumar S (Husband of Mrs. Shivamma) was representing India and worked as a yoga teacher for Jawaharlal Nehru Cultural Centre (JNCC), Embassy of India, in Moscow during 1995 - 2000. Later he moved to India and continues to run an international yoga school at the same premises as the homestay. His yoga school is affiliated to Yoga Alliance, USA.
