# Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the rating assigned to the bank facilities of Renew Solar Energy (Karnataka) Private Limited (RSKPL) with immediate effect, as the company has repaid the aforementioned term loan in full and there is no amount outstanding under the facility as on date.

#### **About the Company**

RSKPL is a subsidiary of Renew Solar Power Private Limited (RSPPL, rated 'CARE A+ (SO)', holding 51% stake) and balance 49% stake is held by Hareon Solar Singapore Private Limited (HSS, solar holding company of Hareon Group of China). RSPPL is a wholly owned subsidiary of Renew Power Ventures Private Limited (RPVPL, rated 'CARE A+', 'CARE A1+') and is a holding company of the solar assets of the group. RSKPL has set up a 60 MW solar PV capacity in Andhra Pradesh, 39 MW at Adoni, District Kurnool and 21 MW at Cumbum, District Prakasham using multi-crystalline technology.

The projects at Adoni and Cumbum achieved Commercial Operation Date (COD) on March 4, 2016 and March 8, 2016, respectively. The projects have been set up at a total cost of Rs.483.14 crore (Rs.8.05 crore/MW). The company is supplying power to Southern Power Distribution Company of Andhra Pradesh Limited (APSPDCL) under long-term PPAs for the entire capacity for a period of 25 years from COD.
