CARE REAFFIRMS THE RATINGS ASSIGNED TO THE BANK FACILITIES OF

SINGHI CABLES AND CONDUCTORS PVT. LTD.

Rating Rationale

The ratings assigned to the bank facilities of Singhi Cables and Conductors Pvt. Ltd. (SCCPL) continue to be constrained by its relatively small scale of operations in a highly fragmented and competitive industry, susceptibility of profitability margins to volatile raw material prices and working capital intensive nature of operations.

The aforesaid constraints are partially offset by the long track record and experience of the promoters in the industry, comfortable capital structure and satisfactory order book position.

SCCPL's ability to grow its scale of operations while improving its profitability margins combat the pressure of volatility in raw material prices & effective management of working capital would be the key rating sensitivities.

Background

Singhi Cables and Conductors Pvt. Ltd. (SCCPL), incorporated in October 1989 by two brothers Mr Ashok Kr Agarwalla and Mr Suresh Kr Agarwalla, based out of Jorhat, Assam, is engaged in manufacturing of aluminium conductors and PVC cables. In 2008-09, the company commenced the production of PVC cables and also entered into the execution of rural electrification projects on a turnkey basis under Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY). The product portfolio comprises All Aluminium Alloy Conductors (AAAC), All Aluminium Conductors (AAC), Aluminium Conductors Steel Reinforced (ACSR), stay wire, aluminium alloy wire and PVC cable. The manufacturing facility of the company is located at Titabor in Jorhat, Assam with an installed capacity of 6,375 MTPA for aluminium conductors and 6,750 MTPA for PVC cables. The cables and conductors find its application in power generating and distributing companies. The customer base of the company comprises State Electricity Boards (SEBs). Besides the company also executes contracts for private parties which in turn receive orders from SEBs.

SCCPL has an associate concern i.e. Win-Power Infra Pvt. Ltd. (rated CRISIL BB/A4+), engaged in construction of extra high voltage (EHV), high- and low-tension power transmission lines and substations. The total operating income of Winpower Infra Pvt. Ltd. stood at Rs.120 crore in FY14 (refers to the period April 1 to March 31).

In FY14, the company achieved a total operating income of Rs.14.69 crore and PAT of Rs.0.70 crore as against a total operating income of Rs.18.66 crore and PAT of Rs.1.24 crore in FY13. Furthermore, in FY15 (Provisional), the company has maintained to have achieved a turnover of around Rs.24.88 crore.
