## CARE ASSIGNS 'CARE BB' RATING TO THE BANK FACILITIES OF SPARK GREEN ENERGY AHMEDNAGAR LIMITED

#### **Rating Rationale**

The ratings on bank facilities of Spark Green Energy Ahmednagar Limited (SGEAL) are constrained by lack of track record of the promoters in biomass energy generation business and cost over-runs on account of delay in the commissioning of 25-MW biomass power project.

However, the rating constraints are strengthened by the company's plan to start commercial production in June 2015 and the long-term power purchase agreement with secured payment mechanism. Furthermore, the rating also considers abundant fuel supply availability along with government regulations eliminating competition in biomass procurement. Going forward, the stabilization of plant and achieving operational efficiency would be the key rating sensitivity.

#### Background

Incorporated in December 2003, SGEAL promoter by Mr Sunil A. Chawla, Mr Sanjay A. Chawla and Mr Amarlal Chawla. The company is setting up 25-MW biomass-based power plant in Ahmednagar, Maharashtra. Ahmednagar has abundant biomass availability in form of sugarcane trashes, cotton, wheat, maize, bajra and jawar.

The total project is expected to beRs.212 crore of which Rs.179 crore has been incurred as on March 31, 2015. The plant was commissioned in October 2014. However, due to delay in getting connectivity to the state power grid, commercial operation of the plant got delayed. Now, power grid connectivity is in place and final commercialization is expected to be in June 2015. The company has long-term power purchase agreement (PPA) with BEST (Brihanmumbai Electric Supply & Transport Undertaking) for supply of power at discounted tariff rates (discount @ Rs. 0.5 per unit for first 5 years) in lieu of the interest free deposits provided by BEST.
