CARE REAFFIRMS THE RATINGS ASSIGNED TO BANK FACILITIES OF UAL INDUSTRIES LIMITED

Rating Rationale

The ratings continue to draw strength from experience of the promoters, UAL Industries Limited's (UAL's) satisfactory track record, strategic plant locations, established market position in eastern India's asbestos market, lack of cost-effective substitute products and comfortable leverage ratios. The ratings also take into cognizance of improvement in financial performance of UAL in H1FY15 (refers to the period April 1 to September 30). The ratings are however, constrained by, susceptibility of profitability margins to the prices of the key raw material, decline in the PBILDT & PAT during FY14, major dependence on rural economy having high correlation with monsoon & harvesting, intense competition in the industry and regulatory and environmental issues surrounding asbestos. The ability of the company to improve its profitability margin, maintain comfortable capital structure, derive desired benefits out of expansion projects and possible impact of any adverse regulations/restrictions with respect to the use of asbestos will remain the key rating sensitivities.

Background

UAL, incorporated in 1974, is currently under the ownership of Mr A. K. Saraf and his family. The company is engaged in the manufacturing of asbestos cement sheets (corrugated and plain) and moulded accessories with aggregate manufacturing capacity of 430,000 metric tonnes per annum (MTPA) at three locations. The company has also started manufacturing Autoclaved Aerated Concrete (AAC) blocks with an installed capacity of 300,000 cubic meters per annum. The company markets its products under the brand name 'Konark'. UAL is one of the leading Asbestos Cement Corrugated (ACC) sheet manufacturers in eastern India.

UAL earned PBILDT of Rs.32.2 crore and PAT (after deferred tax) of Rs.12.5 crore on net sales of Rs. 447.8 crore in FY14 (refers to period the April 1 to March 31). During the 6 months ended September 30, 2014, UAL has achieved PAT of Rs.18.90 crore on a turnover of Rs.245 crore.
