I, Ashish Kumar Jain, Proprietor of M/s. A K Jain & Co., Company Secretaries, Mumbai, have been appointed as Scrutinizer by the Board of **CARE Ratings Limited** to conduct the postal ballot of the Company pursuant to Section 108 and 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, as and when amended and read with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020 and General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021 and General Circular No.20/2021 dated December 8, 2021 issued by Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Secretarial Standard - 2 on General Meetings as issued by the Institute of the Company Secretaries of India for passing of the proposed Ordinary Resolution as mentioned in the Postal Ballot Notice dated January 28, 2022 (hereinafter referred to as **'The Postal Ballot Notice'**).

I submit my report as under:

- 1. I have given my consent to act as Scrutinizer vide letter dated January 27, 2022 and was appointed as Scrutinizer for Postal Ballot including remote e-Voting by a Resolution passed by the Board of Directors on January 28, 2022.
- The Company has completed the dispatch of the postal ballot notice through email on February 21, 2022 to its members whose names appeared in the Register of Members / Records of Depositories as on February 11, 2022.



- 3. The Company has appointed National Securities Depository Limited (NSDL), the authorized agency to provide remote e-voting facility to the Members, who were eligible to take part in the voting process.
- 4. As per Rule 22(3) of the Companies (Management and Administration) Rules, 2014, an advertisement in newspapers in regard to dispatch of Postal Ballot Notice to the members of the Company, was published by the Company in Business Standard in English and Navshakti in Marathi on February 22, 2022.
