Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated March 30, 2021, placed the rating(s) of Green View Udyog Private Limited (GVUPL) under the 'issuer non-cooperating' category as GVUPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GVUPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 13, 2022, February 23, 2022, March 05, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Assam based Green View Udyog Private Limited (GVUPL) was incorporated in 2009 to setup a manufacturing unit of PVC pipes. Since its inception, the company has been engaged in manufacturing of polyvinyl chloride (PVC) pipes & fittings. The pipes and fittings manufactured by the company find application in irrigation, agriculture, potable water supply, sewerage & drainage systems, tube wells etc. The manufacturing facility of the company is located at Guwahati, Assam with an installed capacity of 2880 metric tons per annum (MTPA). Mr. Gajen Kalita, having around three decades of experience in this line of business, looks after the day to day operations of the company. He is supported by other promoters Ms. Purabi Talukdar, Ms. Momi Talukdar and Ms. Moon Talukdar along with a team of experienced professional.
