### Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated April 26, 2021, placed the rating(s) of BSK Agrofeeds Private Limited (BAPL) under the 'issuer non-cooperating' category as BAPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 12, 2022, March 22, 2022, April 01, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

West Bengal based BSK Agrofeeds Private Limited (BAPL) was founded in 2006 to initiate a poultry feed manufacturing business. However, the company has started its commercial production at Jamalpur in Burdhan during February 2018 with an installed capacity of 2,16,000 MTPA. The company sells its poultry feeds in local poultry farms. The day-to-day affairs of the company are looked after by Mr. Bishnu Bose (director) along with other three directors and a team of experienced personnel.
