Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 24, 2021, placed the rating(s) of Bareilly Highways Project Limited (BHPL) under the 'issuer non-cooperating' category as BHPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 10, 2022, May 20, 2022, May 30, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

BHPL is a special purpose vehicle (SPV) promoted by Era Infra Engineering Ltd (EIEL) and OJSC- Sibmost (Sibmost) to undertake 4-laning of the existing 2-lane road from Km 262.0 to Km 413.2 (total project length of 156.57 km) on NH-24 from Bareilly to Sitapur in state of Uttar Pradesh under National Highways Development Programme (NHDP) Phase III of NHAI (rated 'CARE AAA') on Design, Build, Finance, Operate & Transfer (Toll) basis.
