Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 05, 2021, placed the rating(s) of D And M Cables Private Limited (DMCPL) under the 'issuer non-cooperating' category as DMCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. DMCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 21, 2022, May 31, 2022, June 10, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Delhi based D and M Cables Private Limited (DMCPL) was incorporated in July, 2013 and started its commercial operations from May, 2014. The company is currently managed by Mr. Mool Chand Aggarwal, Mr. Amit Aggarwal and Mrs. Dropadi Aggarwal. The company is engaged in the manufacturing of wires and cables i.e. aluminum wire rods, electrical cables & wires (high voltage), conductors and connectors such as coaxial cables, control cables, PVC thermocouple cables, etc. used for overhead transmission and distribution of electricity. The manufacturing facility of the company is located at Sonipat; Haryana.
