Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated November 24, 2021, placed the rating(s) of CCCL Infrastructure Limited (CIL) under the 'issuer non-cooperating' category as CIL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. CIL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated October 10, 2022, October 20, 2022, October 30, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

CIL was established in 2007 as a subsidiary of Consolidated Construction Consortium Limited (CCCL). CIL operates a Solar Power plant of 5-MW capacity at Sekkarakudi in Tuticorin district of Tamil Nadu. The plant is spread over an area of 44 acres and commissioned its operations in February 2012.
