## **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated October 14, 2021, placed the rating(s) of Dashmesh Rice Mills\_(Tarn Taran) (DRMT) under the 'issuer non-cooperating' category as DRMT had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. DRMT continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 30, 2022, September 09, 2022, September 19, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
