## **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated June 02, 2021, placed the rating(s) of G. S. Radiators Limited (GSRL) under the 'issuer non-cooperating' category as GSRL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GSRL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 18, 2022, April 28, 2022, May 08, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

# Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The revision in the ratings assigned to the bank facilities of GSRL was due to non-availability of requisite information. The revision also factored in decrease in scale of operation with overall profitability led to deterioration in capital structure as well as debt coverage indicators in FY21 over FY20.
