Detailed Rationale & Key Rating Drivers

CARE has been seeking no default statement from SPS Spinning Mills (S.P.S) to monitor the ratings vide e-mail communications dated April 14, 2021 etc. and numerous phone calls. However, despite our repeated requests, the firm has not provided no default statement for monitoring the ratings. In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the publicly available information which however, in CARE's opinion is not sufficient to arrive at a fair rating. The ratings on SPS bank facilities will now be denoted as **CARE BB-; Stable; ISSUER NOT COOPERATING***
