Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated August 03, 2021, placed the rating(s) of Kirti Gold Limited (KGL) under the 'issuer non-cooperating' category as KGL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KGL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 19, 2022, June 29, 2022, July 09, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

KGL was incorporated in December 2003 and is a part of the Latur-based (Maharashtra) Kirti group (KG) of companies. The group consists of six closely held public limited companies - KDML, KATL, KAVL, KGL, KFL and KSL all of which are engaged in the business of solvent extraction and oil refining and largely deal in soya bean oil and sunflower oil. Apart from solvent extraction, the group is also involved in dal milling through a proprietorship concern Kirti Udhyog also based in Latur.
