Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 08, 2021, placed the rating(s) of Ajit Construction Company (ACC) under the 'issuer non-cooperating' category as ACC had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ACC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 24, 2022, June 03, 2022, June 13, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The entity takes tender based contracts for its projects where it majorly caters to Madhya Pradesh Rural Road Development Authority (MPRRDA) and PMGSY (Pradhan Mantri Gram Sadak Yojana) scheme. The firm procures raw materials like cement, ready mix concrete, steel and plumbing material, etc. from local suppliers across Madhya Pradesh.
