#### **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated May 03, 2021, placed the rating(s) of BSC C&C Kurali Toll Road Limited (BCKTRL) under the 'issuer non-cooperating' category as BCKTRL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BCKTRL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 19, 2022, March 29, 2022, April 08, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

#### **About the Company**

BSC C&C Kurali Toll Road Limited (BSC) is a Special Purpose Vehicle (SPV) incorporated in February 2007 by BSCPL Infrastructure Limited (BSCPL Infrastructure Limited; rated CARE BB; Stable / CARE A4 as per PR dated April 07, 2021) and C&C Constructions Limited, which currently holds 51% and 49% stake in the company, respectively. The SPV is for the purpose of widening of an existing 44.60 km long, 2- lane stretch between Kurali and Kiratpur to 4- lane and stretching and maintenance of existing 2- lane section The total cost of the project was Rs. 408.10 crore funded through equity of Rs. 104.18 crore (24%), NHAI grant of Rs. 43.92 crore (11%) and Debt of Rs. 260 crore (65%). The project has achieved COD in August 2011.
