Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 05, 2021, placed the rating(s) of Kotecha Industries Limited (KIL) under the 'issuer non-cooperating' category as KIL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KIL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 21, 2022, March 31, 2022, April 10, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company is engaged into the trading Poly Vinyl Chloride (PVC) resin in domestic markets based on the orders given by customers. KIL has set up its unit in Rajkot and has a branch office and a warehouse in Mumbai. The PVC resin is procured from suppliers spread across India as well as is imported from South Korea.
