Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 07, 2021, placed the rating(s) of Ganpat Rai Kewal Ram Trading Co. Private Limited (GRKRTCPL) under the 'issuer non-cooperating' category as GRKRTCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise agreed to in its Rating Agreement. GRKRTCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 23, 2022, May 03, 2022, May 13, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
