Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated August 10, 2021, placed the rating(s) of L. B. Kunjir (LBK) under the 'issuer non-cooperating' category as LBK had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. LBK continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 26, 2022, July 06, 2022, July 16, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of LBK have been revised on account of non-availability of requisite information.

L.B. Kunjir (LBK) promoted by Mr. Laxman Kunjir and his son Mr. Amit Kunjir is a partnership firm incorporated in April 2002. LBK is engaged in construction of earthen dams, canals and barrage projects in the State of Maharashtra. The firm also has investments in wind generation facilities, of 7.35-megawatt (MW) generation capacity by way of power purchase agreements (PPA) for its 6-wind mill for the electricity generated to Maharashtra and Rajasthan State Electricity Board.
