Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 23, 2021, placed the rating(s) of Dee Vee Projects Limited (DVPL) under the 'issuer non-cooperating' category as DVPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. DVPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 08, 2022, June 18, 2022, June 28, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

DVPL was incorporated in June 2012 by Mr. Nanji Bhai Patel. DVPL took over all the assets and liabilities of the erstwhile partnership firm of the same promoters, viz. M/s Patel Enterprises, with effect from April 1, 2013. M/s Patel Enterprises commenced construction business in 1989. DVPL undertakes construction work of buildings, roads, and housing projects for state government agencies in Chhattisgarh, Madhya Pradesh and Maharashtra.
