Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 24, 2021, placed the rating(s) of Annapurna Dal Mill (ADM) under the 'issuer non-cooperating' category as ADM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ADM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 10, 2022, August 20, 2022, August 30, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Annapurna Dal Mill (ADM) was set up as a proprietorship entity in 2004 by Mr Shiv Kumar Agrawal for setting up a manufacturing unit for processing of pulses. However, ADM was constituted as a partnership firm via partnership deed dated January 09, 2015 by Mr Shiv Kumar Agrawal and his family members. Since its inception, the firm has been engaged in milling and processing of pulses like massor and moong dal. The plant of the firm is located at Gaya, Bihar with an installed capacity of 20 metric ton per day.
