Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 07, 2021, placed the rating(s) of Jai Mata Di Ginning And Pressing Factory (JMDGPF) under the 'issuer non-cooperating' category as JMDGPF had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement.
