## **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated September 01, 2021, placed the rating(s) of Mubasa Electrical Private Limited (MEPL) under the 'issuer non-cooperating' category as MEPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 18, 2022, July 28, 2022, August 07, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

#### About the Company

MEPL was incorporated in 1997 and is currently being managed Mr Sanjeev Kumar and Mr Charanjit Singh. The company is engaged in the manufacturing of distribution transformers with capacities ranging from 6.3 KVA to 1,000 KVA at its manufacturing facility located at Patiala, Punjab. The raw materials used in manufacturing are copper wire/rod, aluminium wire/rod, transformer oil, brass fittings, ceramic insulators, press board, etc, which are procured domestically from manufacturers based in Rajasthan, Haryana, Punjab, Bangalore, Mumbai, etc. The company sells its products under the brand name of "MUBASA" to the State Electricity Utilities which include Punjab State Electricity Board, Dakshin Haryana Bijli Vitran Nigam Limited and Uttar Haryana Bijli Vitran Nigam. The company receives the orders through tenders and bidding process. MEP is ISO 9001:2008 certified for its quality management systems.
