Detailed Rationale & Key Rating Drivers

CARE had, vide its press release dated November 20, 2020, placed the rating(s) of K R B S Jewelery Private Limited (KRBSJPL) under the 'issuer non-cooperating' category as KRBSJPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KRBSJPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated October 06, 2021, October 16, 2021 and October 26, 2021.

In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the best available information which however, in CARE's opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KRBSJPL have been revised on account of non-availability of requisite information. The rating also factored in significant decline in profitability and debt coverage indicators during FY20 over FY19.

About the Company

KRBSJPL was originally operating in the name of "R. Balasubramanian Jewelry", established in 1950 by Mr Balasubramanian, as a proprietorship company. It was engaged in manufacture and retailing of jewelry. Mr Balasubramanian was also engaged in manufacture of T-Shirts through another proprietorship "RBS Exports". Subsequently, with the view to increase the scale of operations, private limited company was established in the name KRBSJPL on July 10, 2012. In June 2013, the business of jewelry and garments was taken over by KRBSJPL and the commercial operations of the company commenced.
