#### **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated April 01, 2021, placed the rating(s) of North Street Cooling Towers Private Limited (NSCTPL) under the 'issuer non-cooperating' category as NSCTPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. NSCTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 15, 2022, February 25, 2022, March 07, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
