Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 26, 2021, placed the rating(s) of Bhoday Steel Rolling Mills (BSRM) under the 'issuer non-cooperating' category as BSRM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercises agreed to in its Rating Agreement. BSRM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 11, 2022, April 21, 2022, May 01, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
