Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 10, 2021, placed the rating(s) of Maa Sarala Agritech Private Limited (MSAPL) under the 'issuer non-cooperating' category as MSAPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MSAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 26, 2022, April 05, 2022, April 15, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Maa Sarala Agritech Private Limited (MSAPL), incorporated in 2017, commenced operation from February 2019. The company is engaged in processing and milling of boiled rice. The milling unit of Maa Sarala Agritech Private Limited is located at Manijanga, Jagatsinghpur, Odisha, with installed capacity of 12,000 MTPA. MSAPL procure paddy from government, farmers & local agents and sells its products through the wholesalers and distributors across Odhisa along with that also does custom milling of Rice (CMR) for Govt. The Company has two directors namely Mr. Navin Agarwal and Mr. Deepak Ranjan Sahoo. Mr. Navin Agarwal has around 14 years of experience in rice milling and processing business. Both the directors look after the overall management of the company, with adequate support from a team of experienced personnel.
