Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 03, 2021, placed the rating(s) of Blue Duck Textiles Private Limited (BDTPL) under the 'issuer non-cooperating' category as BDTPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BDTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 19, 2022, April 30, 2022, May 09, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Ghaziabad-based (Uttar Pradesh) BDTPL was originally incorporated in the year 1948 as a private limited company under the name of Webbing and Belting Factory Private Limited for carrying out the business of fabric dyeing and printing industry. It was later rechristened to BDTPL in April, 2013, to engage in the business of printing and dyeing of white fabric. BDTPL is promoted by Mr. Shantanu Kaul and Mrs. Gitanjali Kaul and currently operates from its sole manufacturing unit located in Sikandrabad (Uttar Pradesh).
