Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 07, 2021, placed the rating(s) of Ecomotel Hotel Limited (EHL) under the 'issuer non-cooperating' category as EHL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. EHL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 23, 2022, September 02, 2022, September 12, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Ecomotel Hotel Limited (EHL) is a special purpose vehicle promoted by Celebrations, a part of the Celebrations Group which operates multiple specialty theme luxury hotels and resorts in Central India and LCL, a Hindustan Construction Company Limited (HCC) group company. EHL operates a mid-priced 130 room hotel at Lavasa under the brand name 'Mercure Lavasa'. The hotel's built up area is around 77,000 square feet with 97 standard rooms, 31 superior rooms and 2 family rooms. Also, the hotel operates four inhouse restaurants suiting different requirement of customers. The hotel is operated by AAPC Singapore PTE Limited (Mercure Hotels) who are paid 6% of gross room rent as operating fees, in addition to other fees as per agreement.
