Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 20, 2021, placed the rating(s) of Gati Infrastructure Private Limited (GIPL) under the 'issuer non-cooperating' category as GIPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 06, 2022, August 16, 2022, August 26, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Gati Infrastructure Pvt Ltd. (GIPL) is a special purpose vehicle (SPV) promoted by Mr. M K Agarwal & associates along with his group company – Amrit Jal Ventures P Ltd. (AJVPL) to set up a 110 MW run-of-the-river, Chuzachen hydro-electric project (HEP) in the state of Sikkim. The project is located on the tributaries of Teesta River - Rangpo and Rangli, in east Sikkim. The project was awarded to GIPL under an implementation agreement entered into between Government of Sikkim (GoS), Sikkim Power Development Company (SPDC) for a period of 35 years from commercial operating date (COD).
