Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated March 03, 2021, placed the rating(s) of Gokul Hi Fashions (GHF) under the 'issuer non-cooperating' category as GHF had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GHF continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 17, 2022, January 27, 2022 and February 06, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

Gokul Hi Fashion (GHF) is a partnership firm established in October, 2010 by Mr. S. Saravana, Mr. K. Raju, Mr. R. Mohan Kumar and Mr. R. Balachandran. Mr. R. Mohan Kumar and Mr. R. Balachandran retired from partnership business from March 31, 2012. Mr. S. Sarvanan retired from the firm and Mrs. Sugandhi (Wife of Mr. K. Raju) joined as a partner since April 01, 2018. GHF is engaged in manufacturing and export of hosiery garments. The manufacturing unit is located at Tirupur (Tamil Nadu) and has production capacity of 12000 pieces per day.
