Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated March 02, 2021, placed the rating(s) of Hariman Seeds (HS) under the 'issuer non-cooperating' category as HS had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. HS continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 16, 2022, January 26, 2022, February 05, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sitarganj (Uttarakhand) based Hariman Seeds (HS) is a partnership firm and was established in October, 2017. The commercial operation was expected to start from February, 2019, and is currently being managed by Mr Amit Kumar Agarwal, Mr Rahul Agarwal and Mr Harish Agarwal. HMS procures paddy from local grain markets through open market situated locally. HMS is primarily targeting sells its product through brokers and commission agents in Northern India viz. Uttarakhand, export to Africa, UAE to wholesalers, traders. The procurement of paddy normally depends on moisture content and portion of rice in paddy, after which it is dried and polished.
