### Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 05, 2021, placed the rating(s) of Athaluri Sushma Sree (ASS) under the 'issuer non-cooperating' category as ASS had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ASS continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 21, 2022, August 31, 2022, September 10, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Firm

AthaluriSushmaSree (ASS) was established in the year 2012, as a proprietorship concern by Mrs. AthaluriSushmaSree. The firm is engaged in Godown leasing business. ASS has constructed Godowns in Koiloor Village, Yadgir District, and Karnataka during April 2013 for lease purpose. The firm started receiving rental income from June 2014. The property is built on total land area of 12 acres comprising 4Godowns (Sai Radhika Rural Godowns) having storage capacity of 20,000 MT per Godown. ASS has entered into agreement with Karnataka State Warehousing Corporation (KSWC) for warehouse leasing for tenure of 10 years. The firm is undertaking a project for construction of warehouse at Belgaum on land area of 12 acres comprising of 5 godowns having storage capacity of 25000 MT per godown.
