Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 07, 2021, placed the rating(s) of Guranditta Mal Mohan Lal (GMML) under the 'issuer non-cooperating' category as GMML had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GMML continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 23, 2022, September 02, 2022, September 12, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Guranditta Mal Mohan Lal (GMML) was established in 1978 as a partnership firm. The firm is currently being managed by Mr Adarsh Kumar and Mr Roshan Lal as its partners sharing profit and losses equally. The firm is engaged in processing of paddy at its manufacturing facility in Fazilka, Punjab. GMML sells basmati and non-basmati rice directly to various wholesalers based in Delhi, Chandigarh, Haryana, Maharashtra and Punjab. The raw material, primarily paddy, is procured from local grain markets located in Punjab only.
