Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 12, 2021, placed the rating(s) of Om Cottex (OC) under the 'issuer non-cooperating' category as OC had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. OC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 28, 2022, April 07, 2022, April 17, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Botad (Gujarat) based Om Cottex (OC) was established in 2008 as a partnership firm. Currently, OC is managed by six partners with unequal profit and loss sharing agreement between them. OC is into the business of cotton ginning & pressing and crushing of cotton seeds. While cotton bales are used in manufacturing of cotton yarn, cotton seeds are further processed for extraction of edible oil. OC operates from its sole manufacturing facility located in Botad (Gujarat) and has an installed capacity of 6048 metric tons per annum (MTPA) for cotton bales, 756 MTPA for cotton seed oil & 5418 MTPA for cake as on March 31, 2016. OC markets its products in the states of Gujarat, Tamil Nadu and Maharashtra.
