Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 06, 2021, placed the rating(s) of Gayatri Cotton Mills (GCM) under the 'issuer non-cooperating' category as GCM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GCM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 22, 2022, September 01, 2022, September 11, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Gayatri Cotton Mills (GCM) was established in June 2012 as a partnership firm by Mr. Innamuri Basavaiahand Mr. Innamuri Subrahmanyam. The firm is engaged in manufacturing and processing of Kappas into cotton lint. The firm has its facilities (14 ginners and 1 cotton baling press) located at Guntur District of Andhra Pradesh. The firm acquires cotton directly from the farmers and after ginning, sells the same in the domestic market.
