Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated August 30, 2021, placed the rating(s) of Niha International Private Limited (NIPL) under the 'issuer non-cooperating' category as NIPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. NIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 16, 2022, July 26, 2022, August 05, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company was originally incorporated in February 1998 by Mr. Murari, Mr. Krishna Prasad and Mr. Narayanan. However, it was non-operational since its inception and was subsequently taken over by the current directors of NIPL in 2002.
