Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 07, 2021, placed the rating(s) of Mahalaxmi Oil Mill (MOM) under the 'issuer non-cooperating' category as MOM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MOM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 23, 2022, May 03, 2022, May 13, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of MOM have been revised on account of non-availability of requisite information.

MOM is a partnership firm engaged in manufacturing maize oil and maize oil cake used as cattle feed. The partners of the firm are Mr Mansukh Bhagat (65% share), Mr Premchand Patel (15% share), Mr Hitesh Patel (10% share) and Mr Manoj Velani (10% share). The manufacturing facility of the firm is located in Dhansura Taluka of Gujarat with an installed capacity of 100 tonnes crushed per day (TCD). MOM sells its product variants under the brand name of 'Mewad King'.
