### **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated July 13, 2021, placed the rating(s) of Jai Maa Sharda Agro and Rice Mills Private Limited (JMSARMPL) under the 'issuer non-cooperating' category as JMSARMPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. JMSARMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 29, 2022, June 08, 2022, June 18, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the Company**

Incorporated in February, 2010, JMSARMPL, was promoted by Mr. Ajay Kumar Kejriwal and his three brothers, to set up a rice processing & milling unit of non-basmati rice and sale of its by-products like husk, bran etc. in the domestic market. The plant, having an installed capacity of 48,000 metric tonnes per annum (MTPA), is situated in Burdwan district of West Bengal, a major paddy growing area and in close proximity to local grain market enabling easy paddy procurement. Furthermore, JMSARMPL has sorting capacity of 5 tons/hour.
