## **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated August 23, 2021, placed the rating(s) of Micro Motion India Private Limited (MMIPL) under the 'issuer non-cooperating' category as MMIPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MMIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 09, 2022, July 19, 2022, July 29, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

# Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. The ratings also consider an increase in overall debt in FY21 compared to FY20.

The company, having its manufacturing facility in Kala Amb (Himachal Pradesh), is engaged in the manufacturing of corrugated boxes and mono cartons from kraft paper along with their printing and lamination according to the client requirements.
