Rationale and key rating drivers

The revision in the ratings assigned to the bank facilities of MSTC Limited (MSTC) factors in the consistent improvement in the profitability margins and debt coverage indicators of the company with increase in revenue from the higher margin e-commerce business. The ratings also factor in the reduced working capital intensity of operations with significant scaling down of the trading business and consequent reduction in debt level.

The ratings continue to draw strength from the established position of the company in the e-commerce business leading to stable source of revenue from service income and Government of India's (GoI) controlling stake in the company.

The ratings, however, continue to remain constrained by the high average collection period, high total outside liabilities as a proportion of tangible net-worth (TOL/TNW), on-going litigations against the company, customer concentration and exposure to intense competition with tender based nature of business in e-commerce.

CARE Ratings Limited has withdrawn the ratings assigned to certain long-term bank facilities of MSTC with immediate effect, as the company has repaid/surrendered the limits in full to its lenders and there is no amount outstanding under the facilities as on date.

Rating sensitivities: Factors likely to lead to rating actions

Positive factors

- Significant improvement in sales from the e-commerce segment
- Significant improvement in collection period with recovery from debtors
- Sustaining the improvement in profitability margins
- Improvement in TOL/TNW below 2x

Negative factors

- Moderation in operating profitability
- Increase in overall gearing beyond 0.75x
- Any unfavourable outcome of the on-going litigations impacting the credit risk profile of the company.

Analytical approach: Standalone

Outlook: Stable

The stable outlook reflects that MSTC is expected to continue deriving advantage from its established position in the e-commerce business, especially for its government clientele which along with the favourable demand scenario should enable it to sustain healthy business risk profile over the medium term supported by a comfortable financial risk profile.

Key strengths

Long track record of the company with GoI's controlling stake and Mini Ratna I status

MSTC was set up in September 1964 for regulating export of ferrous scrap from India. Since 1991, MSTC has been in direct marketing of melting scrap, coke/coal, iron ore and many other products. Over the years, it has added various new products and services in its portfolio. MSTC is a Mini Ratna Category-I PSU of GoI, based in Kolkata. Although the government had reduced its stake to 64.75% through IPO of MSTC in March 2019, GoI continues to have a controlling stake in the company.

Shift in focus to e-commerce segment and significant reduction of trading business

MSTC earns stable service income through the e-commerce business. The direct trading sales and service income from trading through facilitator mode (majorly purchase of raw material for secondary steel producers and petrochemical industry) has been

gradually reducing with shift in focus towards the e-commerce business. In the facilitator mode, MSTC only does order-backed purchases and currently all contracts are backed by bank guarantee of 110% of the procurement value from the customer. The Total Operating Income (TOI) witnessed an increase of about 11% in FY22 due to increased revenue from e-commerce segment. Income from e-commerce segment increased by 33% y-o-y to ₹294 crore in FY22 vis-à-vis ₹221 crore in FY21.

The company has been providing diversified e-commerce services mainly to government entities ranging from tendering, bidding, online platform for buy and sale, license auctions, scrap disposals, etc. The company is likely to benefit from the gradual shift to digital mode by GoI.

Improvement in overall gearing with significant decline in debt level

The total outstanding debt reduced to ₹149.50 crore as on March 31, 2022 as compared to ₹154.39 crore as on March 31, 2021. Accordingly, the overall gearing ratio improved from 0.44x in as on March 31, 2021 to 0.32x on March 31, 2022. As the company has shifted its focus from trading business to e-commerce business, the requirement for working capital borrowings has reduced significantly. The outstanding debt of ₹149.50 crore reflects term loan of ₹4.50 crore for purchase of new office building and ₹145 crore accounted for sub-judice liability towards Standard Chartered Bank (SCB) and Indian Overseas Bank (IOB). However, TOL/TNW remained high at 3.35x as on March 31, 2022. The company has a significant amount of security deposits/deposits received from customers, against which there is a significant amount of cash also outstanding in the books.

As on December 31, 2022, total outstanding debt only pertained to the sub-judice liability and the company has repaid/surrendered all other debt.

Improvement in profitability

With higher profitability in the e-commerce segment, the company continued to witness improvement in the PBILDT margin to 24.46% in FY22 (PY: 17.15%). With higher operating profit despite the impact of write-offs/provisions on past debtors and reduction in interest cost, PAT margin improved to 28.96% in FY22 (PY: 16.28%). The improvement continued in 9MFY23 with PBILDT of 50.42% and PAT margin of 51.86%.

Key weaknesses

High collection period

The receivables reduced to ₹408 crore as on March 31, 2022, from ₹724 crore as on March 31, 2021. Average collection period decreased significantly to 322 days (PY: 888 days) with increase in TOI along with the reduction in receivables. Despite reduction, the collection period remains high. However, a large part of receivables (mainly from the trading business) are either backed by 110% bank guarantees or backed by similar amount of creditors. As on September 30, 2022, the total receivables amounted to around ₹350 crore.

Customer concentration; albeit reduced in FY22

One customer of MSTC in trading segment contributed about 21% of total revenue in FY22 vis-à-vis two customers contributing about 29% in FY21 and about 71% in FY20. The reduction of trading business has helped in reduction of the concentration. In the e-commerce segment, about 90% of the revenue is mainly earned from various public sector enterprises. The company is looking at gradually increasing its business from the private sector.

Intense competition

Trading industry is highly fragmented with a few large PSUs and a large number of private players in the fray. Accordingly, the company faces intense competition which impacts its profitability. In the selling agency business, there is risk of the customer directly selling the product. In the e-commerce segment as well, it faces significant competition from other portals. The orders from government entities are procured through tendering process.

On-going litigations against the company

During FY09, MSTC exported gold jewellery worth ₹638.21 crore to 46 customers based in UAE Singapore and Kuwait through six jewellery manufacturers/merchants (called Associates) based in Mumbai. Out of this, foreign export bills for about ₹184.66 crore were sold to SCB under factoring arrangement without recourse. The payments from Dubai based customers were due in 2009 and the debtors did not honour the payment commitment.

MSTC had filed legal suits aggregating ₹658.40 crore in different forums against the 46 buyers. The company has got judgement in its favour for all the 46 cases and approached the appropriate courts for execution. However, no payment was received.

Against the total amount of receivables purchased by SCB, a balance amount of ₹143.62 crore remained outstanding as on March 31, 2021. SCB had insured the total amount of receivables purchased by them with ICICI Lombard (ICICIL) in case of a default in payment by the debtors. SCB had filed a suit against ICICIL in the Hon'ble Bombay High Court for payment of claim and has

got ex-parte decree in its favour. ICICI Lombard subsequently had filed allowed a Notice of Motion setting aside the ex-parte decree. The matter is presently sub-judice.

MSTC has shown liability in its books for ₹143.62 crore (as borrowings with corresponding debtors) and interest payable of ₹78.89 crore (as other financial liabilities) as on March 31, 2022 (same as on March 31, 2021).

MSTC had approached the Hon'ble Bombay High Court against auction program by Debt Recovery Tribunal (DRT) to sell attached immovable properties of MSTC. Hon'ble Bombay High Court had stayed the auction program as well as the recovery proceedings upon deposit of ₹55.63 crore with the Court, due to vacancy in DRAT. On the assumption of Chairperson at DRAT, the stay now stands vacated and the amount has been transferred to DRAT. DRAT has further ordered to deposit ₹34.37 crore as pre deposit for hearing the appeal. MSTC has since deposited the amount and with this total deposit stands at ₹90 crore. The DRAT in its order dated November 9, 2022 had dismissed the appeal. Against that order, MSTC had filed writ petition with Hon'ble Bombay High Court. The Hon'ble Bombay High Court in its order dated January 17, 2023 has restored the appeal with DRAT. In the light of Hon'ble Bombay High Court's order restoring the appeal, proceedings are in abeyance.

Any adverse outcome of the legal proceedings impacting the credit risk profile is a key rating sensitivity.

Liquidity: Adequate

The liquidity position of the company is adequate. The cash accruals are healthy and currently there are no debt repayment obligations. The company at present does not have any sanctioned fund-based working capital limits or bank guarantees. It uses bank guarantees fully backed by fixed deposits for its requirements. It does not have significant capital expenditure plans.

Environment, social, and governance (ESG) risks

The company participates in initiatives towards addressing environmental issues, like introducing scrappage policy. The company during FY22 spent ₹0.24 crore for various Corporate Social Responsibility (CSR) projects and initiatives. Its board composition is in line with the regulatory requirements.
