Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 10, 2023, placed the rating(s) of Rausheena Udyog Limited (RUL) under the 'issuer non-cooperating' category as RUL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. RUL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated November 26, 2023, December 06, 2023, March 05, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Rausheena Udyog Ltd (RUL) was incorporated in 1998 by Shri Saroj Agarwal in Shillong, Meghalaya. RUL's operation is categorized in 3 divisions namely processed food division, engineering division and trading division. The processed food division manufactures ready to eat food products and supplies to government for the various nutrition program of state and central government. The engineering division manufactures steel casting products and supplies to Indian Railways. The trading division supplies school bags, sweaters, etc. to government institutions. The company has successfully increased its food division capacity from 5,400 MTPA to 10,800 MTPA at a cost of Rs.10.5 crore in Jan 2017.
