Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 10, 2023, placed the rating(s) of Sri Selvanaayaki Textile (SST) under the 'issuer non-cooperating' category as SST had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SST continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 27, 2023, January 06, 2024, January 16, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Sri Selvanaayaki Textile (SST) is a proprietorship concern established in the year 1989 by Mr. R. Palanisamy. The firm is primarily engaged in the manufacture of grey fabrics. The promoter is also supported by his wife Mrs. P. Indumathi in handling the operations. SST procures raw material (cotton) from suppliers located in India. The firm has sizing units. Each of the units have an installed capacity of about 7200 kgs of yarn per day. After sizing of yarn in the firm, the weaving process is outsourced to job workers in and around Coimbatore. SST also exports its fabrics to Mali, West Africa.
