### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 20, 2023, placed the rating(s) of Hitkari Gram Udyog Sangh (HGUS) under the 'issuer non-cooperating' category as HGUS had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. HGUS continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 06, 2023, December 26, 2023, April 03, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Currently Mr. Ajay Kumar, Mr. Nafe Singh Solanki, Mr. Pawan Gupta, Mr. Rajinder Kumar, Mr. Ravi Kumar, Mr. Chander Parkash and Mr. Rajiv Juneja are its members. They collectively look after the overall operations of the society. HGU is engaged in manufacturing of detergent powder which involves detergent cake and dish washing bar. HGU procures the raw material i.e. linear alkyl benzene sulphonic acid from suppliers like Aaditya Fine Chem Private Limited, DJ Surfactants etc. located in Udaipur, Rajasthan.
