Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 19, 2023, placed the rating(s) of RajShri Constructions (RC) under the 'issuer non-cooperating' category as RC had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. RC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 05, 2023, December 15, 2023, December 25, 2023.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Uttar Pradesh based, Rajshri Construction (RC) was established in July, 2009 as a partnership firm and is currently being managed by Mr. Sanjeev Goel, Mr. Deepak Goel, Ms. Mamta Goel and Ms. Monica Goel. The firm is engaged in construction of roads for government departments in the regions of Uttar Pradesh and Uttarakhand. The raw materials namely, gravel (rodi), tar coal etc., the firm procures from various domestic wholesalers based in Uttar Pradesh, Haryana and Uttarakhand.
