# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 03, 2023, placed the rating(s) of N E Infra (NEI) under the 'issuer non-cooperating' category as NEI had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. NEI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 20, 2023, December 30, 2023, January 09, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of NEI have been revised on account of non-availability of requisite information.

Since its inception, the firm has been engaged in civil construction activities in the segment like construction of bridge, building, etc. NEI is classified as 'Class 1(A)' contractor by the Assam Government which enables it to participate in higher value contracts. NEI secures work contracts through tender and executes orders mainly for Public Work Department (PWD), Assam Tourism Development Corporation Limited and various departments of Assam Government.
